Appeal of Ray M. Paternostro v. Assessor Errol G. Williams and Orleans Parish Board of Review, Docket No. 23-22174-025 (*Deferred from the 3/13/2024 Appeals Hearing*)

The Taxpayer, Ray Paternostro presented on behalf of himself. Mr. Paternostro is requesting that the value of the subject property to be set at \$237,000 (\$162,000 for the Land and \$75,000 for the improvements).

Russell Almaraz testified for the Assessor's office. Mr. Almaraz requested that the value of the subject property be set at \$292,000 (\$162,000 for the Land and \$130,000 for the Improvements).

Necole Singley testified as to her appraised value of \$292,000. (\$198,000 for the land and \$94,000 for the Improvements).

Commissioner Romig moved that the value of the subject property be set at \$292,000. (\$162,000 for the land and \$130,000 for the Improvements).

There being no objection to the motion, the motion is adopted.

Appeal of Daniel E. Haro v. Assessor Errol G. Williams and Orleans Parish Board of Review, Docket No. 23-22172-023

The Taxpayer, Daniel E. Haro presented on behalf of himself. Mr. Haro is requesting that the value of the subject property to be set at \$430,000 (\$306,000 for the Land and \$123,400 for the improvements). Taxpayer agrees with the LTC value.

Russell Almaraz testified for the Assessor's office. Mr. Almaraz requested that the value of the subject property be set at \$710,000 (\$306,600 for the Land and \$403,400 for the Improvements).

Cody Lowery testified as to his appraised value of \$430,000. (\$306,600 for the Land and \$123,400 for the improvements).

Commissioner Frazier moved that the value of the subject property be set at \$430,000 (\$306,600 for the Land and \$123,400 for the Improvements).

There being no objection to the motion, the motion is adopted.

## Appeal of Val C. Cupit v. Assessor Errol G. Williams and Orleans Parish Board of Review, Docket No. 23-22172-006

The Taxpayer, Val C. Cupit testified on behalf of herself and the Taxpayer Representative, Charles Emile Bruneau presented on behalf of the taxpayer. The Taxpayer requested that the value of the subject property to be set at \$120,000 for the land.

Russell Almaraz testified for the Assessor's office. Mr. Almaraz requested that the value of the subject property be set at \$183,000 for the land.

Cody Lowery testified as to his appraised value of \$225,700 for the land.

Commissioner Romig moved that the value of the subject property be set at \$183,000 for the land.

There being no objection to the motion, the motion is adopted.

## Appeal of James L Perrien v. Assessor Errol G. Williams and Orleans Parish Board of Review, Docket No. 23-22176-040

The Taxpayer, James L Perrien was not presented. Mr. Perrien is requesting that the value of the subject property to be set at \$390,000 (\$140,900 for the Land and \$249,100 for the improvements). The Taxpayer agrees with the LTC value.

Russell Almaraz testified for the Assessor's office. Mr. Almaraz requested that the value of the subject property be set at \$527,000 (\$140,900 for the Land and \$389,300 for the improvements).

Markae Palmer testified as to her appraised value of \$390,000 (\$140,900 for the Land and \$249,100 for the Improvements).

Commissioner Romig moved that the value of the subject property be set at \$477,200 (\$140,900 for the Land and \$336,300 for the Improvements).

There being no objection to the motion, the motion is adopted.

The Taxpayer, Roger Jordan presented on behalf of himself. Mr. Jordan is requesting that the value of the subject property to be set at \$725,000 (\$220,800 for the Land and \$504,200 for the improvements).

Russell Almaraz testified for the Assessor's office. Mr. Almaraz requested that the value of the subject property be set at \$1,120,000 (\$294,400 for the Land and \$825,600 for the improvements).

Markae Palmer testified as to her appraised value of \$895,000 (\$294,000 for the Land and \$600,600 for the Improvements).

Commissioner Leone moved that the value of the subject property be set at \$895,000 (\$294,400 for the Land and \$600,600 for the Improvements).

There being no objection to the motion, the motion is adopted.
