CONSIDERATION OF THE 2023 ORLEANS PARISH TAX ROLL

Ms. Malveaux presented and discussed the 2023 Tax Roll submitted for the December 15th, 2022, meeting.

Chairman Chehardy moved to accept and certify the 2023 Tax Roll for Orleans Parish on the basis that the Assessor has confirmed that the 2023 Tax Roll complies with the November 18, 2022 Judgement issued by Judge Omar Mason enjoining the Tax Commission from certifying any tax roll from Orleans Parish if such roll contains certain property of the Folger Coffee Company subject to ITEP applications and on the basis that representatives of the Folger Coffee Company

have reviewed the 2023 Tax Roll for Orleans Parish as submitted and advised in writing that the 2023 Tax Roll does not contain the property at issue. The Tax Commission has independently reviewed the 2023 Tax Rolls for Orleans Parish to ensure compliance with Judges Mason's ruling, but the commission is also relying on the representations of the Assessor and the Taxpayer.

There being no objection to the motion, the motion is adopted.

CONSIDERATION OF THE 2022 AMENDED VERNON PARISH TAX ROLL

Ms. Malveaux presented and discussed the 2022 Amended Vernon Parish Tax Roll submitted for the December 15th, 2022, meeting.

Commission Vercher moved to approve the 2022 Amended Vernon Parish Tax Roll.

There being no objection to the motion, the motion is adopted.


CONSIDERATION OF ANY OTHER MATTERS THAT MAY COME BEFORE THE COMMISSION

The meeting was adjourned at 11:04 a.m.




