Ms. Malveaux testified on behalf of the LTC. Tax Commission staff proposes to update Table 1503 – Aircraft (Including Helicopters) to the new Base Date of January 1, 2023.

Mr. Kret testified on behalf of LAA. Mr. Kret stated in his presentation that the first word of this chapter should begin with "because rather than "when."

2. Louisiana Tax Commission (Tanasha Malveaux)

Ms. Malveaux testified on behalf of the LTC. Tax Commission staff proposes to update Table 2503.B – Cost Indices to the new Base Date of January 1, 2023 and to update Table 2503.D – Composite Multipliers using the newly calculated Cost Indices.

I. Chapter 25- Oil & Gas Properties

1. Louisiana Assessors' Association, Louisiana Mid-Continent Oil and Gas Association, and Louisiana Chemical Association (Bob Adair, Advantous Consultants; Greg Bowser, LCA & Tommy Faucheaux, LMOGA)

Mr. Adair submitted a PowerPoint Presentation to support the groups' proposal. This proposal relates to carbon capture, utilization, and sequestration (CCUS) property, also called CCS. The purpose of this document is not to promote CCUS but recommend uniform guidance for Louisiana property tax valuation of CCUS property where it may be installed. This proposed addition would be a new "Business Activity/Type of Equipment" for Chapter 25 of the Louisiana Tax Commission Rules and Regulations ("LTC rules")..
