In compliance with the Administrative Procedure Act the LA Tax Commission published a Notice of Intent and Emergency Rule in the December 2022 edition of the LA State Register. As required in the Notice of Intent a deadline of January 6, 2023 was set for interested parties to submit written

comments to our office regarding the published changes to the LA Tax Commission's Rules & Regulations for tax year 2023 (2024 Orleans Parish) and a hearing date of January 25, 2023 was set to discuss any written comments received. At the hearing the written comments received were discussed. A Potpourri was published March 20, 2023 reflecting additional changes to the guidelines. A deadline of April 7, 2023 was set for interested parties to submit written comments on those changes and a hearing date of April 26, 2023 was set to hear testimony from written comments received regarding the Potpourri publication. Staff has confirmed there were no written comments received regarding the Potpourri publication.


